

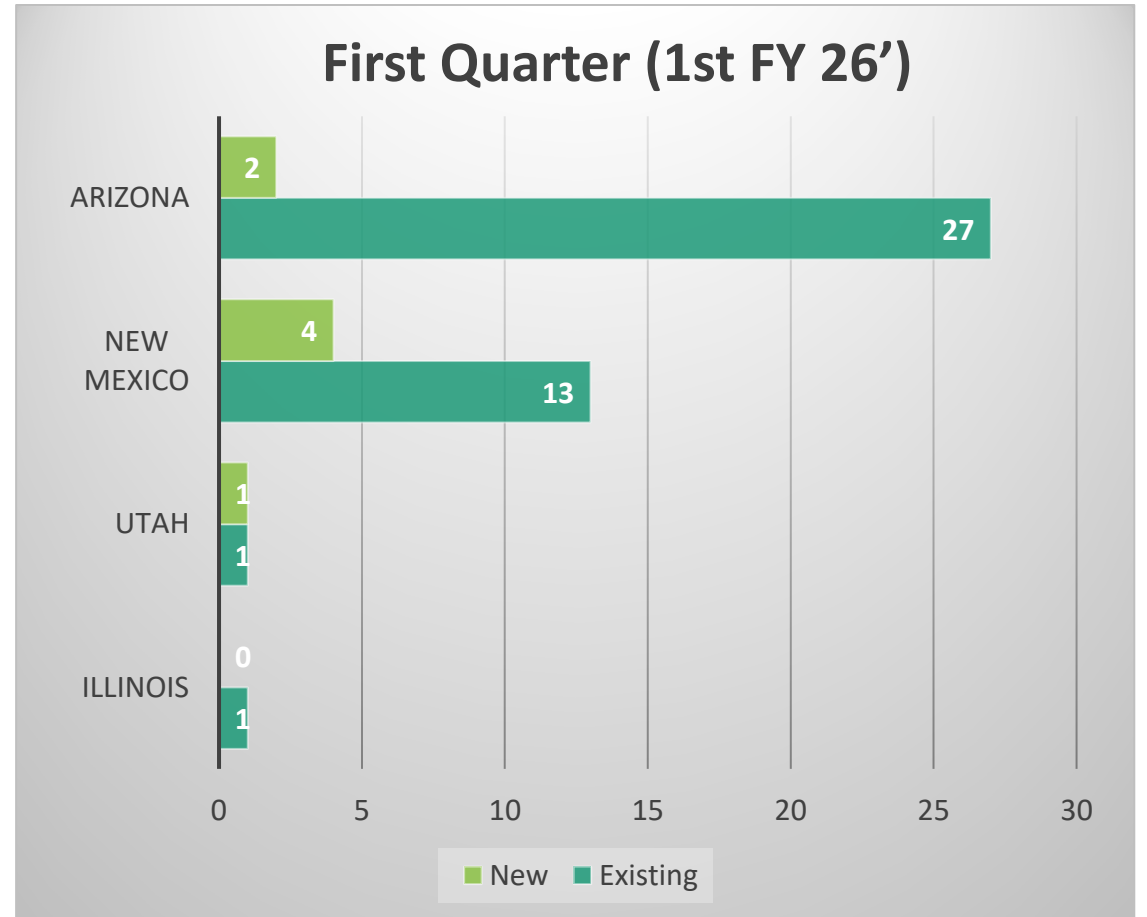
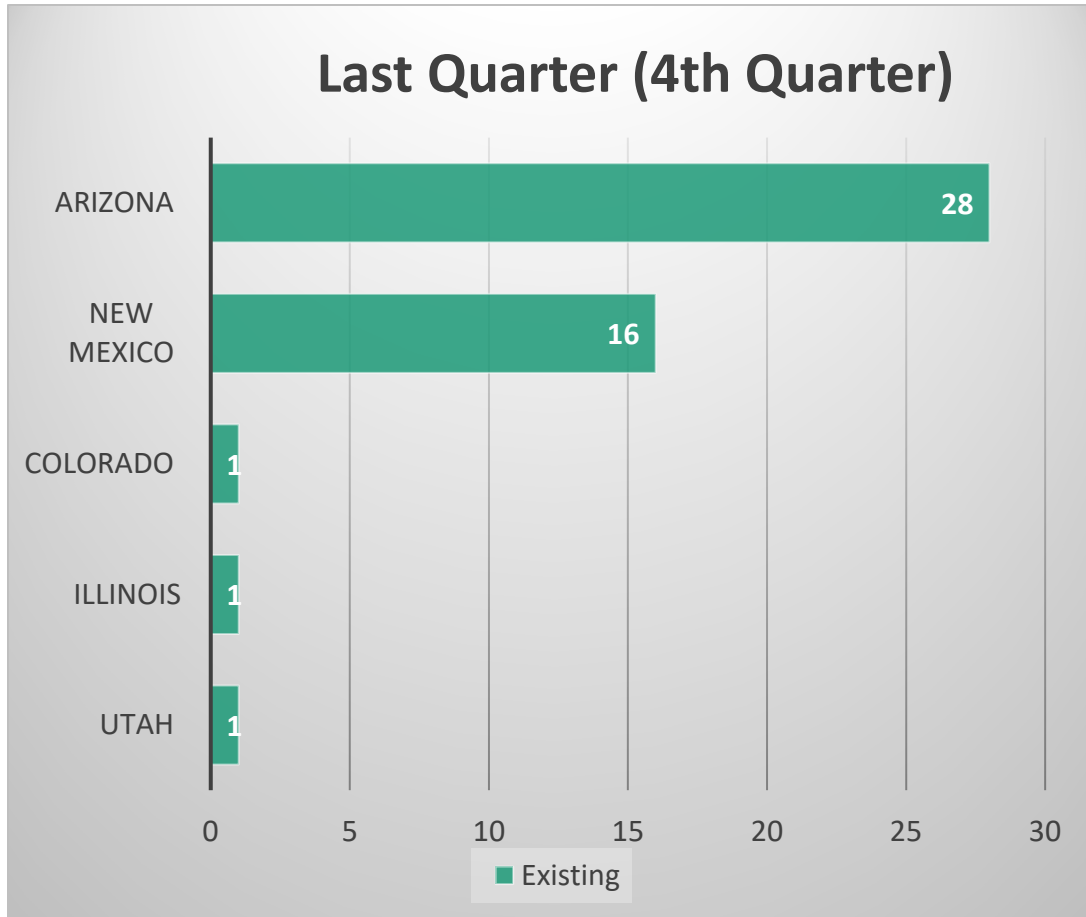
# **Report to the Navajo Nation Human Rights Commission 2026 Fiscal Year – First Quarter Report 49 Total Active Cases**

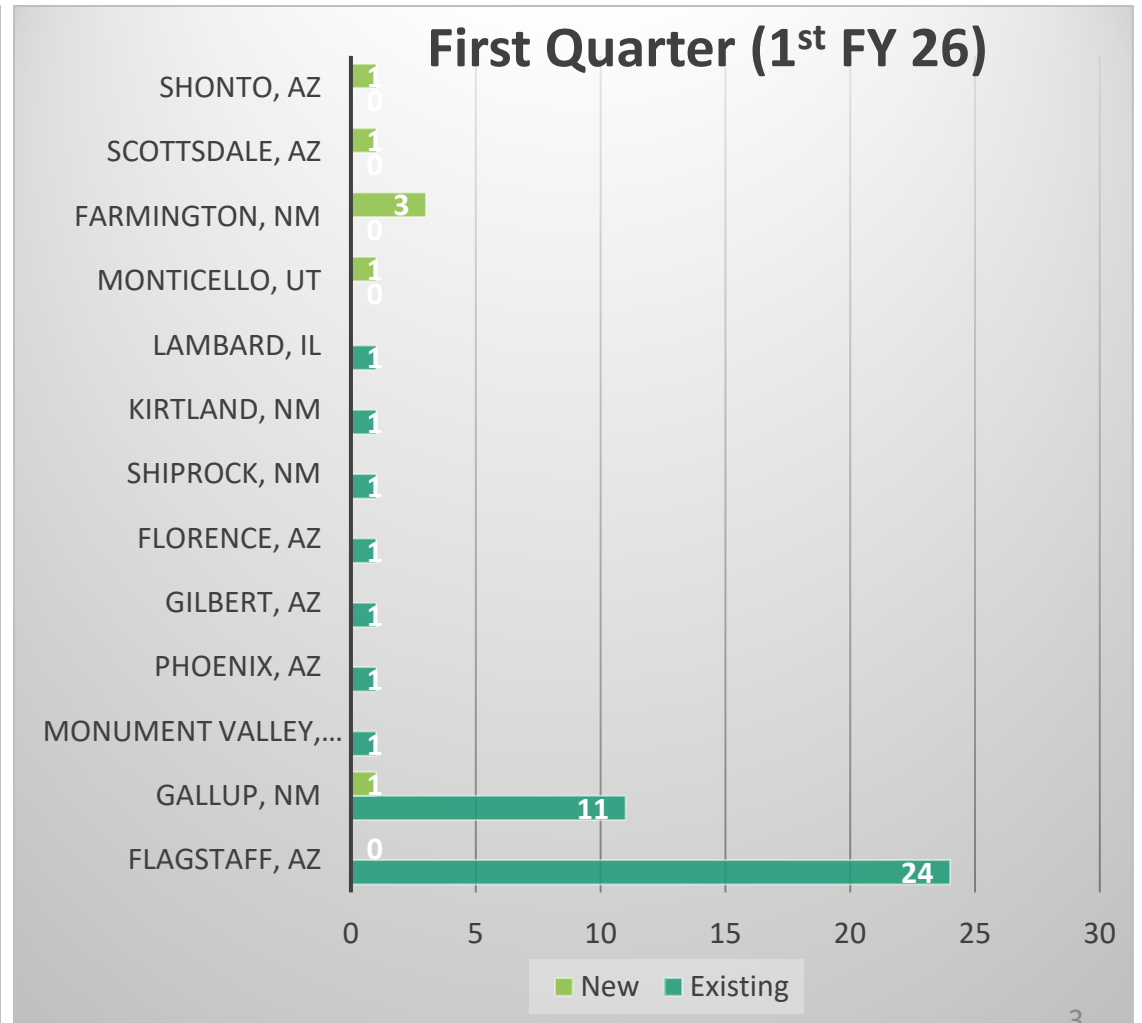
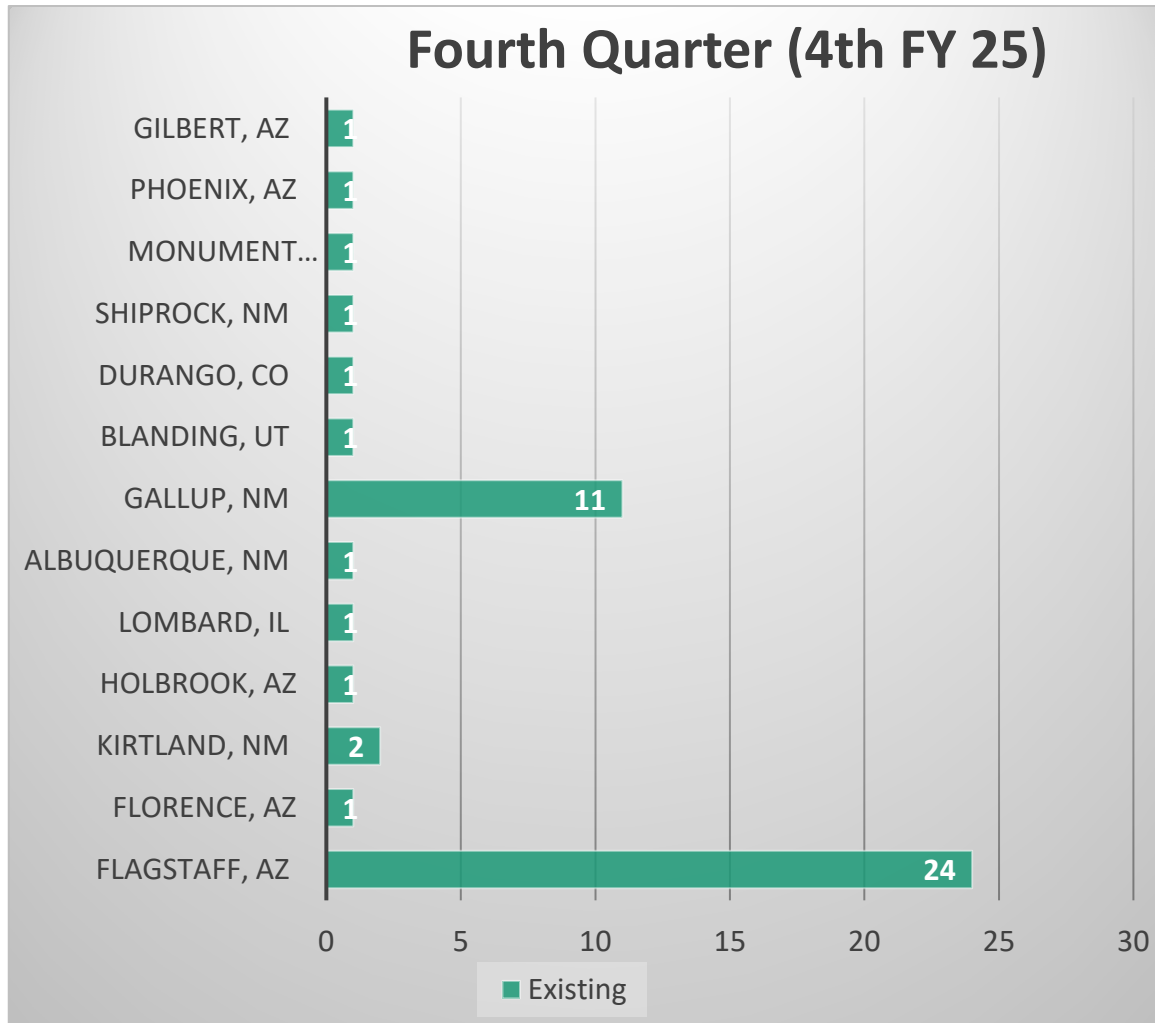
# Complaints by State

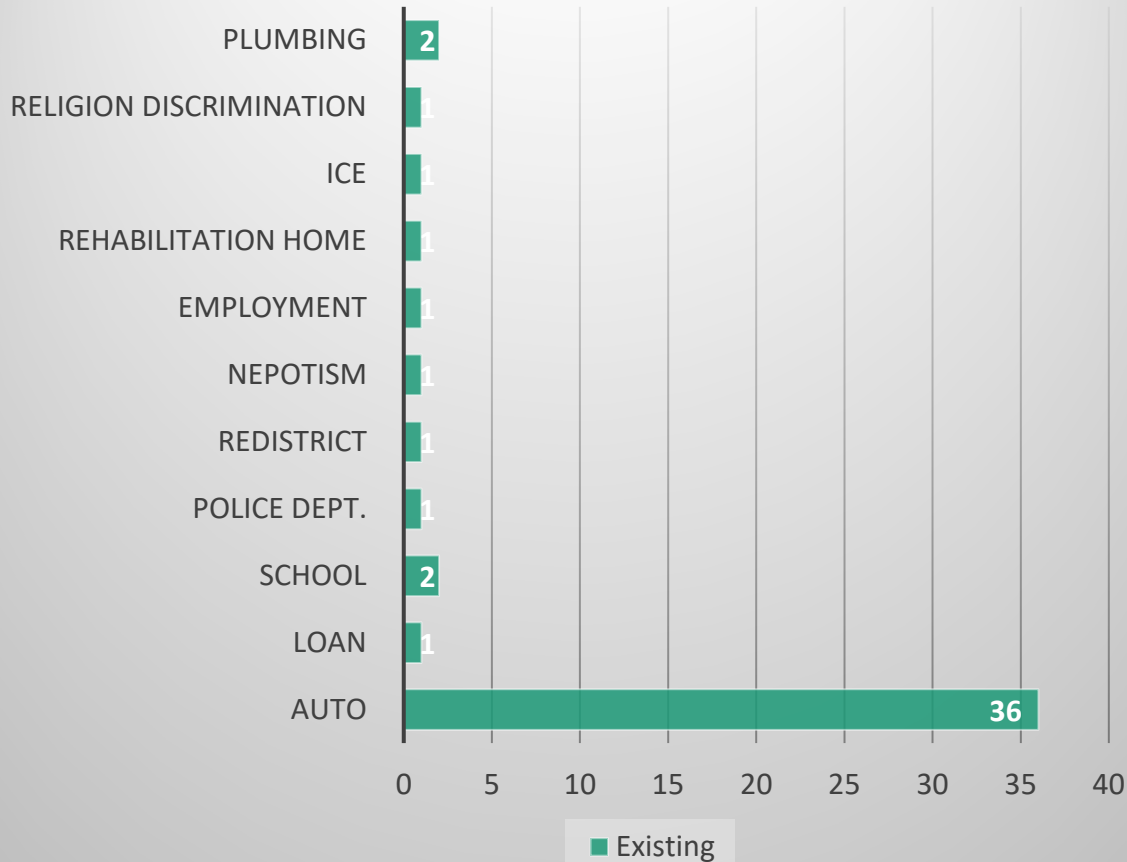

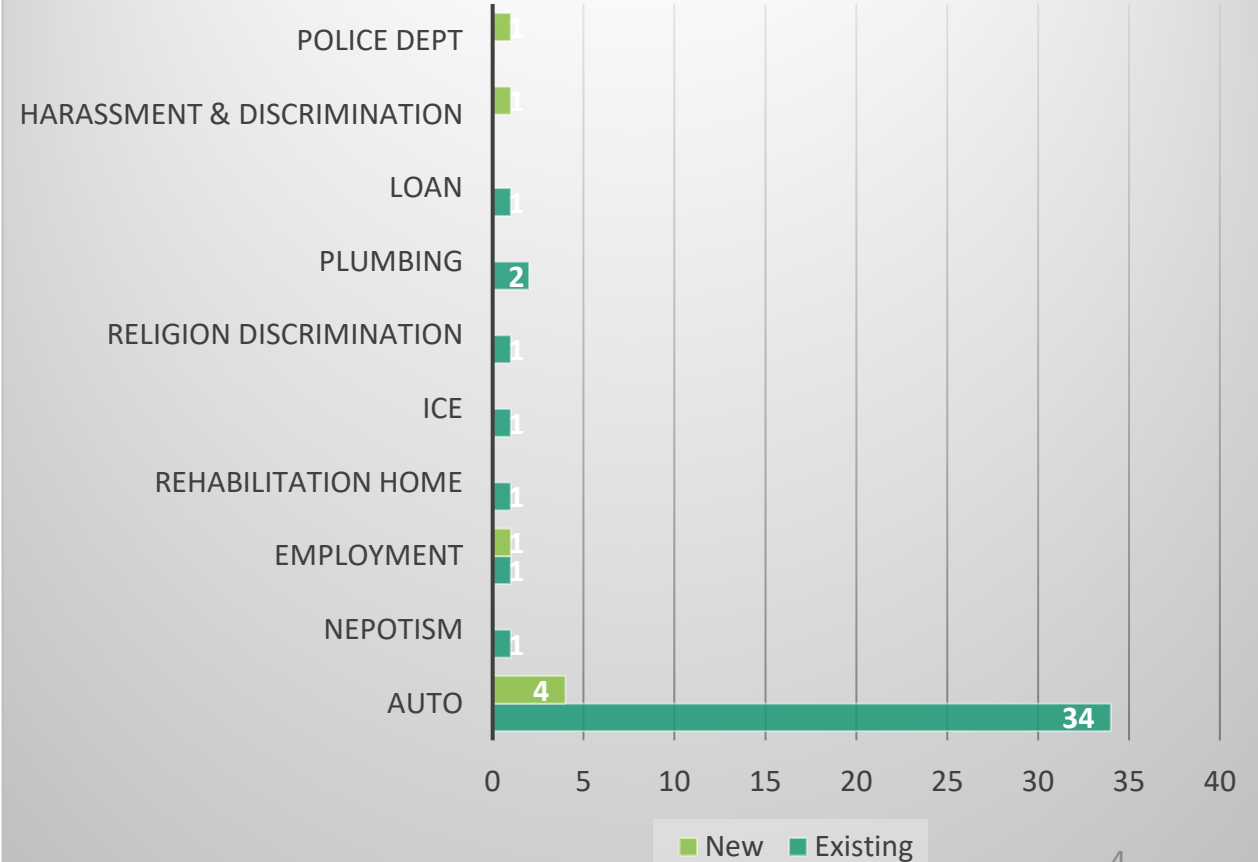

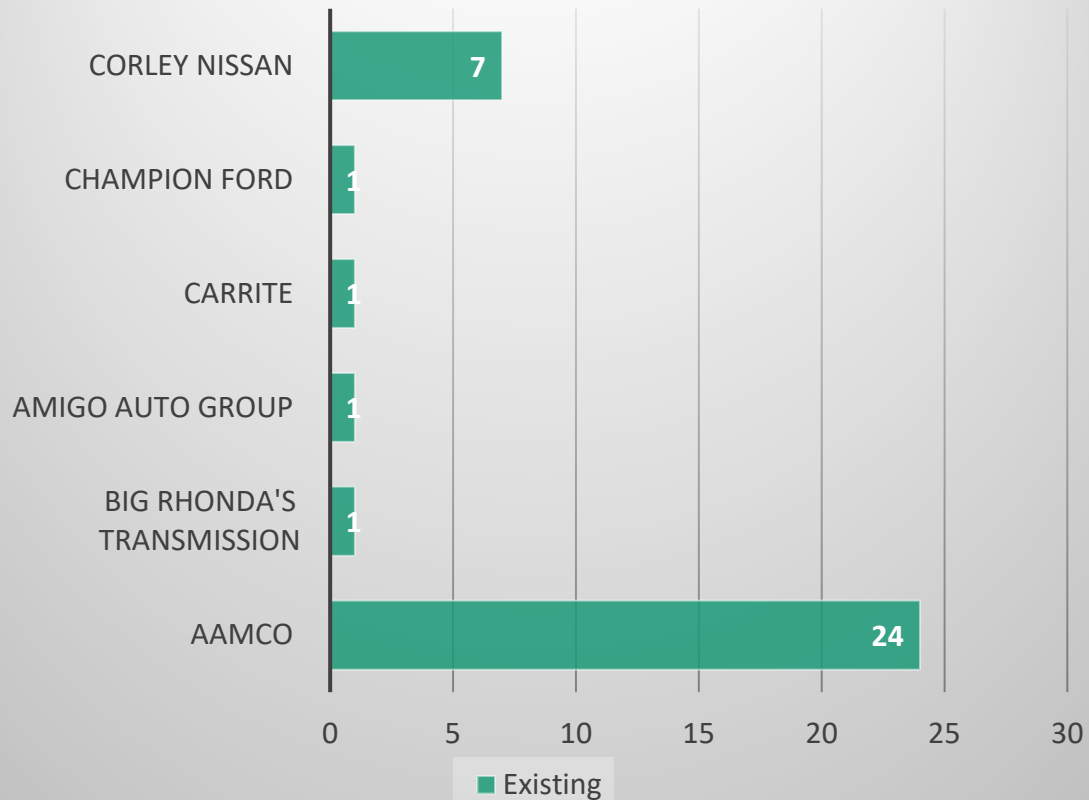

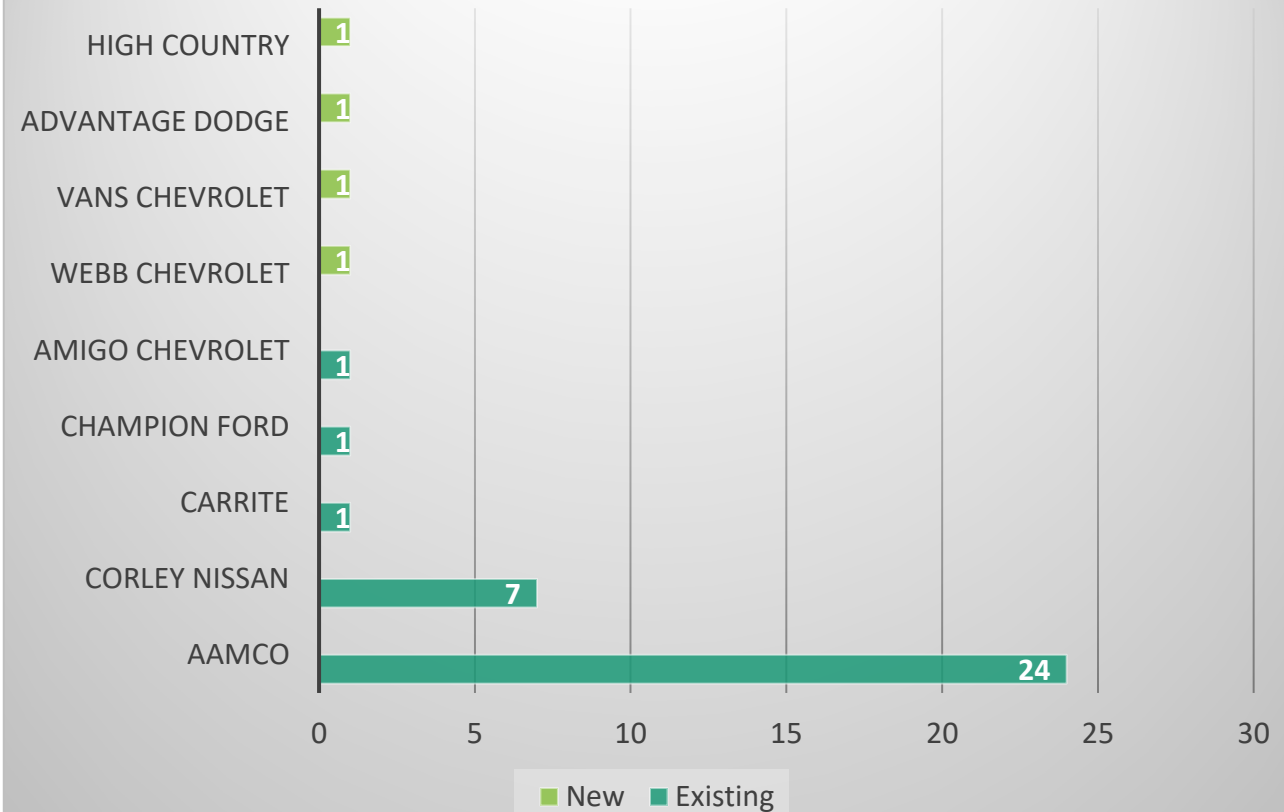
